Administrative

Election of Trustees: Following the Annual Meeting, Sandra Ladd and I documented the in-person ballots and imported the final voting information into the Trust's database. With this information we can review the number of Life Members who voted, the response rate of primary resident votes vs. seasonal residents, etc.

Namskaket Marsh: On September 5th, Judy Scanlon, Lynn Bruneau, and I attended a Namskaket Marsh Ecological Assessment Workshop at Town Hall (handouts and notes from the meeting can be provided upon request). As the meeting came to a close the following recommendations were being tossed around for further consideration and Board of Selectmen review:

- Update/ repeat the vegetation mapping within Namskaket Marsh;
- Compare the new culvert hydraulic capacities vs. former tidal information (i.e., Gather up-to-date information on the marsh's surface water hydrology);
- Look into mitigating "point source" pollution involving Town & State roads;
- Consider further investigating sub-surface geology and groundwater hydrology;
- Review historic clay layer boring logs in detail to determine where the existing wells are and where some wells could go;
- Conduct a sanitary shoreline survey within Namskaket, and
- Update the modeling data associated with the Tri-Town plume and develop new maps based on new information.

Land Management

Release the Turtles: On September 9th OCT and MA Audubon Wellfleet Bay hosted its fourth Diamondback Terrapin release at the White's Lane Conservation Area, drawing 15 volunteers and community members alike. Before releasing the terrapins Bob Prescott discussed how the restoration of the site came to fruition, why it was an ideal site for diamondback terrapins, what efforts are being made to restore the terrapin populations across the Cape,

Paw Wah Point Osprey Pole Installation: At the August 2014 Board meeting the Trustees voted their approval of the installation of an osprey pole at the Paw Wah Point Conservation Area. To date I have received 11 gifts totaling \$875 to go towards offsetting the costs associated with the purchase of the pole and other materials. We estimated a total cost of \$1,000.

White's Lane Controlled Burn: Since 2011 I have investigated the possibility of conducting a controlled burn at the White's Lane Conservation Area. A controlled burn would help knock back woody growth and invasive plant species from the field habitat and diversify the vegetative community. Dave Crary, Fire Management Officer at the Cape Cod National Seashore, and Tim Simmons of the State's Natural Heritage and Endangered Species Program have supported our proposal. This past week I spoke to John Panio, who oversees controlled burns State-wide. He is reviewing a number of documents associated with the conservation area, including our 2009 Landowner Incentive Program grant, and will be back in touch with us to determine what steps need to be taken next.

Educational Meetings/ Programs

Up-coming Walk: On Tuesday, September 16th I led a walk through the Mill Pond Valley Conservation Area off Champlain Road in Orleans.

Up-coming Lecture: On Tuesday, September 23rd we will be hosting a lecture entitled *Cape Cod Commercial Fisherman's Alliance*. Raymond Kane, Education Coordinator for the Alliance will discuss the sustainability of fish populations in the oceans and the livelihood of the local fishermen on Cape Cod.

Recent Walks: On Saturday, September 6th I led a walk through the Town's Kenrick Woods Conservation Area off Namequoit Road in South Orleans. This was a unique walk through large stands of white pine and the very rare American chestnut trees.
